


CONSULTATION ON SEPA'S PROPOSED

1 Purpose

1.1 This consultation seeks your views on charges in 2018/19 and beyond for the work undertaken by SEPA for the Reservoirs (Scotland) Act 2011 and the Reservoirs (Scotland) Regulations 2016 and how we intend to review these charges in 2018.

2 Background

2.1 SEPA consulted in 2015 on the charging scheme (<u>link</u>) for 2015/16 through to 2017/18. The 2015 consultation said that charges would be reviewed in this period. We have reviewed the charges and currently the charges cover our costs <u>however</u> we do not believe the years 2015/16 and 2016/17 provide a suitable measure of "normal" work.

Why does SEPA not consider these years to be representative of "normal" work levels?

- In 2015/16 resource was allocated to developing systems, setting up the team and dealing with registrations.
- In 2016/17 we continued the logging and input of registry information including: ongoing set up of systems, dealing with reservoirs where the reservoir manager was not agreed and had to be resolved, issuing risk designations and processing and responding to representations and reviews associated with these risk designations, supporting and providing guidance to reservoir managers & engineers in complying with the new legislation, as well as what the "normal" work would be.

3 Proposals

- 3.1 While our charges are reflective of costs incurred from 2015 to present, we believe that once the scheme is bedded in, our cost will change. We therefore propose to carry forward the existing scheme for a further year and review the reservoir charges in 2018 after we have collected a representative year of "normal" work. Depending on the conclusions of the review we may change the charging scheme.
- 3.2 For the 2018/19 charges we propose to take account of inflation compared to 2017/18. These charges will take effect from 1st April 2018. The inflationary change would be the Retail Prices Index (RPI) published by the Office for National Statistics as at 30 September 2017.
- 3.3 If the review shows no change is required then charges for subsequent years will be changed in-line with RPI published by the Office for National Statistics, as at 30 September in the immediately preceding year e.g. RPI at 30/9/2019 would be applied to charges in 2019/20 to give the new charge in 2020/21 (and so on).

3.4 The following table summarises the charges for 2018/19.

Registration fee	£523 + RPI at 30th September 2017

High risk reservoir	£434 + RPI at 30th September 2017
Medium risk reservoir	£292 + RPI at 30th September 2017
Low risk reservoir	£178 + RPI at 30th September 2017
Application fee for review of SEPA risk designation	£367 + RPI at 30th September 2017
