1. Condition 2.2.1 is deleted and replaced with a new condition 2.2.1 as follows:
 - 2.2.1 The maximum weight of Atlantic Salmon held at the authorised place at any one time must not exceed 2472.4 tonnes.

6. Condition 3.3.2 is deleted and replaced with a new Condition 3.3.2 as follows:

3.3.2 The quantity of medicines in Table 2 used, whether in a pen or a vessel or a combination of both must not exceed:

- (a) 1366.5 grams of azamethiphos in any 24 hour period.
- (b) 455.5 grams of azamethiphos in any 3 hour period.
- (c) 55 grams of deltamethrin in any 3 hour period.

7. Condition 3.4.3 is deleted and replaced with condition 3.4.3 as follows:

3.4.3 Any discharge of the active ingredient in Table 3 must not exceed the maximum environmental quantity of 19.43 grams.

8. Condition 4.1.3 is deleted and replaced with a new condition 4.1.3 as follows:

4.1.3 The seabed around the fish farm at the boundary of an area of 239,511m² (the "mixing zone") must meet as a minimum an Ecological Quality Ratio (EQR) of 0.64 IQI (Infaunal Quality Index) at any time.

9. Condition 4.2.1 is deleted and replaced with condition 4.2.1 as follows:

4.2.1 Emamectin benzoate concentrations must not exceed 272ng/kg (dry weight) in the seabed at the boundary of the mixing zone.
