The authorisation is varied as follows:

- Condition 2.4 is deleted and replaced by a new condition 2.4 as follows:

2.4 Pen Configuration

2.4.1 The fish pens must be configured as set out in Table 1.

2.4.2 The authorised location of the fish pen group is within an area delineated in Figure 1 and bounded by the pen corner buoys located at the following National Grid References (NGRs):

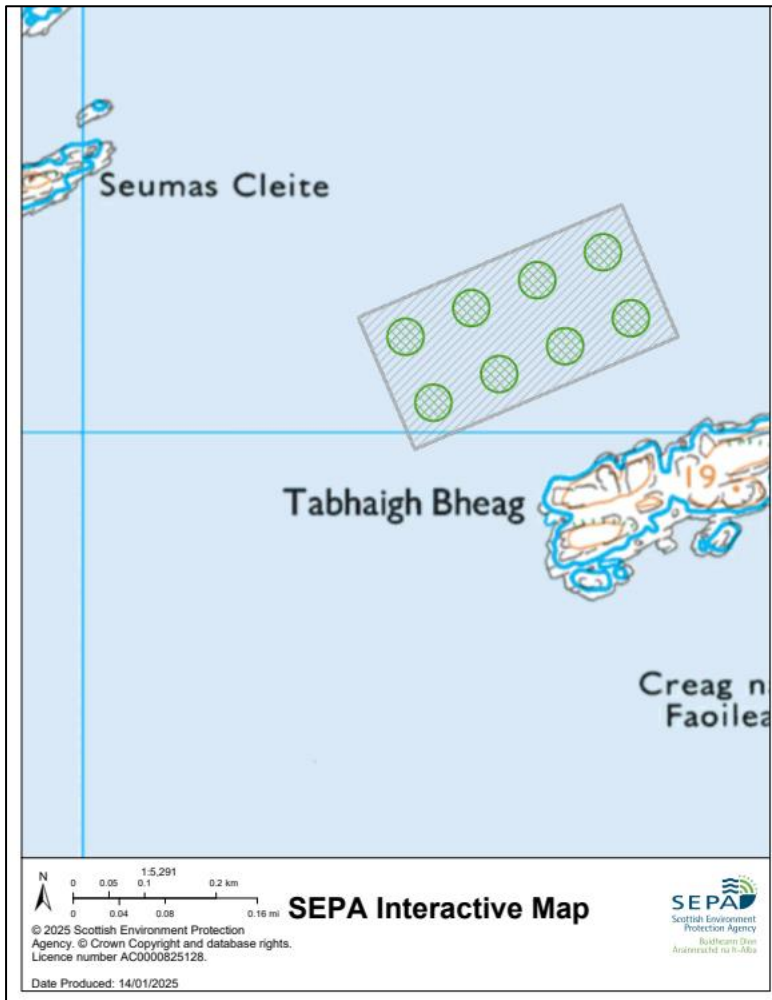
- NB 4138 2316 (NW)

2.4.3 The pen corner buoys must not be located at a distance greater than 50 metres in any direction from the NGRs listed in 2.4.2.

2. Condition 3.3.2 (a) is deleted and replaced by a new condition 3.3.2 (a) as follows:

3.3.2 (a) 1021.0 grams of azamethiphos in any 24 hour period.

3. Condition 3.3.2 (b) is deleted and replaced by a new condition 3.3.2 (b) as follows:

3.3.2 (b) 20.4 grams of deltamethrin in any 3 hour period.

4. Condition 4.1.3 is deleted and replaced by a new condition 4.1.3 as follows:

4.1.3 The seabed around the fish farm at the boundary of an area of 177,116 m² (the “mixing zone”) must meet as a minimum an Ecological Quality Ratio (EQR) of 0.64 IQI (Infaunal Quality Index) at any time.

5. Condition 5.1.1 (a) is deleted and replaced by a new condition 5.1.1 (a) as follows:

5.1.1 (a) The Environmental Monitoring Plan (EMP) Tabhaigh MPFF, EMP/CAR/L/1129793, version 2.0 dated 17 December 2024.

6. Condition 5.3.2 is deleted and replaced by a new condition 5.3.2 as follows:

5.3.2 Samples collected in accordance with 5.3.1 must be collected at a distance of 150m from the outer edge of the W pen on a bearing of 245 degrees.
