## Schedule

The authorisation is varied as follows:

1. Condition 2.2.1 is deleted and replaced with a new condition 2.2.1 as follows:

2.2.1 The maximum weight of Atlantic Salmon held at the authorised place at any one time must not exceed 700 tonnes.

2. Condition 2.4.1 together with Table 1 have been deleted and replaced with a new condition 2.4.1 and a new Table 1 as follows:

2.4.1 The fish pens must be configured as set out in Table 1.

3. Condition 2.4.2, together with Figure 1, have been deleted and replaced with a new condition 2.4.2 and a new Figure 1 as follows:

2.4.2 The authorised location of the fish pen group is within an area delineated in Figure 1 and bounded by the pen corner buoys located at the following National Grid References (NGRs):

1. NN 0320 3304 (S)
2. NN 0315 3310 (W)
3. NN 0352 3336 (N)
4. NN 0357 3330 (E)

4. Condition 3.4.3 is deleted and replaced with a new condition 3.4.3 as follows:

3.4.3 Any discharge of the active ingredient in Table 3 must not exceed the maximum environmental quantity of 101.05 grams.

**5.** Condition 4.1.3 is deleted and replaced with a new condition 4.1.3 as follows:

4.1.3 The seabed around the fish farm at the boundary of an area of 132,388 m<sup>2</sup> (the “mixing zone”) must meet as a minimum an Ecological Quality Ratio (EQR) of 0.64 IQI (Infaunal Quality Index) at any time.

**6.** Condition 5.1.1(a) is deleted and replaced with a new condition 5.1.1(a) as follows:

(a) The Environmental Monitoring Plan (EMP) Etive 3 Port na Mine MPFF, CAR/L/1010366, Version 2.0, dated July 2025.

**7.** Condition 5.3.2 is deleted and replaced with a new condition 5.3.2 as follows:

5.3.2 Samples collected in accordance with 5.3.1 must be collected at a distance of 150m from the outer edge of the east pen on a bearing of 85 degrees.
