

# **Notice: Variation of Permit**

### **Schedule**

The permit has been varied as follows:

- **1.** Paragraph 1.1.4.1 has been deleted and replaced with new Paragraph 1.1.4.1 as follows:
  - 1.1.4.1 Nine poultry housing units with a capacity more particularly described below:
    - a) 178,000 places for pullets.

The locations of the housing units are shown in the Site Plan.

- 2. Paragraph 1.1.5.1 has been deleted and replaced with new Paragraph 1.1.5.1 as follows:
  - 1.1.5.1 Fuel and Raw Material storage carried out in infrastructure more particularly described below:
    - a) Two containers for Gas Oil, used as fuel for back-up generators located as indicated on the Site Plans;
    - b) Tanks for Liquefied Petroleum Gas, used as fuel for space heating located as indicated on the Site Plans;
    - c) A secure refrigerated medicine store.
- **3.** Paragraph 1.1.5.3 has been deleted and replaced with new Paragraph 1.1.5.3 as follows:
  - 1.1.5.3 Water storage carried out using infrastructure more particularly described below:
    - a) Holding tanks.
- **4.** Paragraph 1.1.5.4 has been deleted and replaced with new Paragraph 1.1.5.4 as follows:
  - 1.1.5.4 Storage and disposal of fallen stock. This is carried out using infrastructure more particularly described below:
    - a) A secure and vermin-proof dead box.



- **5.** Paragraph 1.1.5.6 has been deleted and replaced with new Paragraph 1.1.5.6 as follows:
  - 1.1.5.6 Lightly contaminated run off collection, drainage and treatment more particularly described below:
    - a) A wetland at Hallmanor located as indicated on 1.2.1 Detailed Layout Plan of Hallmanor:
    - b) A pond at Glenrath Farm located as indicated on 1.2 Site Plan.
- **6.** Paragraph 1.1.5.7 has been added as follows:
  - 1.1.5.7 Handling of slurries and manures carried out using infrastructure more particularly described below:
    - a) Four underground tanks located as indicated on the Detailed Layout Plans used for the collection of washwater effluent from the housing;
    - b) Litter on a solid floor removed at the end of each cycle.
