The authorisation is varied as follows:

- 1. Condition 2.2.1 has been deleted and replaced with a new condition 2.2.1 as below:
 - 2.2.1 The maximum weight of Atlantic Salmon held at the authorised place at any one time must not exceed 2850 tonnes.
- **2.** Table 1 has been deleted and replaced with a new Table 1 below:


- 3. Condition 2.4.1 has been deleted and replaced with a new condition 2.4.1 below:

- **5.** Condition 3.3.2 has been deleted and replaced with a new condition 3.3.2 below:
 - 3.3.2 The quantity of medicines in Table 2 used, whether in a pen or a vessel or a combination of both must not exceed:
 - a) 2460 grams of azamethiphos in any 24 hour period.
 - b) 1230 grams of azamethiphos in any 3 hour period.
 - c) 32 grams of deltamethrin in any 3 hour period.
 - d) 85 grams of cypermethrin in any 3 hour period.

6. Condition 4.1.3 has been deleted and replaced with a new condition 4.1.3 below:

- 4.1.3 The seabed around the fish farm at the boundary of an area of 177,068m2 (the "mixing zone") must meet as a minimum an Ecological Quality Ratio (EQR) of 0.64 IQI (Infaunal Quality Index) at any time.
