

## Notice: Variation of Permit

## Schedule

The permit has been varied as follows:

1. Paragraph 1.1.4.1 has been deleted and replaced by a new Paragraph 1.1.4.1, as follows:

1.1.4.1 Seven poultry housing units with a capacity more particularly described below:

- a) 129,000 places for poultry in an aviary housing system;
- b) 68,000 places for pullets.

The locations of the housing units are shown in the site plan.

2. Paragraph 1.1.5.4 has been deleted and replaced by a new Paragraph 1.1.5.4, as follows:

1.1.5.4 Handling of slurries and manures carried out using infrastructure more particularly described below:

- a) Underground tanks located as indicated on the Detailed Layout Plans used for the collection of washwater effluent from the housing.
- b) Air drying of manure on conveyor belts in Arranview 2.
- c) Manure collection and removal every 2-3 days using conveyor belts in the layer houses and stored in a covered trailer before uplift offsite.
- d) Litter on a solid floor removed at the end of each cycle.

3. Paragraph 1.1.5.6 has been deleted and replaced by a new Paragraph 1.1.5.6, as follows:

1.1.5.6 Lightly contaminated run off collection, drainage and treatment more particularly described below:

- a) Sediment trap, swale and pond at Arranview located as indicated on the site plan.
- b) Gravel bed filter trench at Jameston Moss
