Partial Surrender and Variation Notice

The Scottish Environment Protection Agency (“SEPA”), in exercise of its functions under Regulations 30(2) and Schedule 1, paragraphs 14 and 15 of the Environmental Authorisations (Scotland) Regulations 2018 (the “Regulations”), grants your application to surrender the authorisation specified below (the “Authorisation”) to the extent and from the Effective date of surrender specified below. SEPA also varies the Authorisation as follows, with effect from the Effective date of variation specified below.

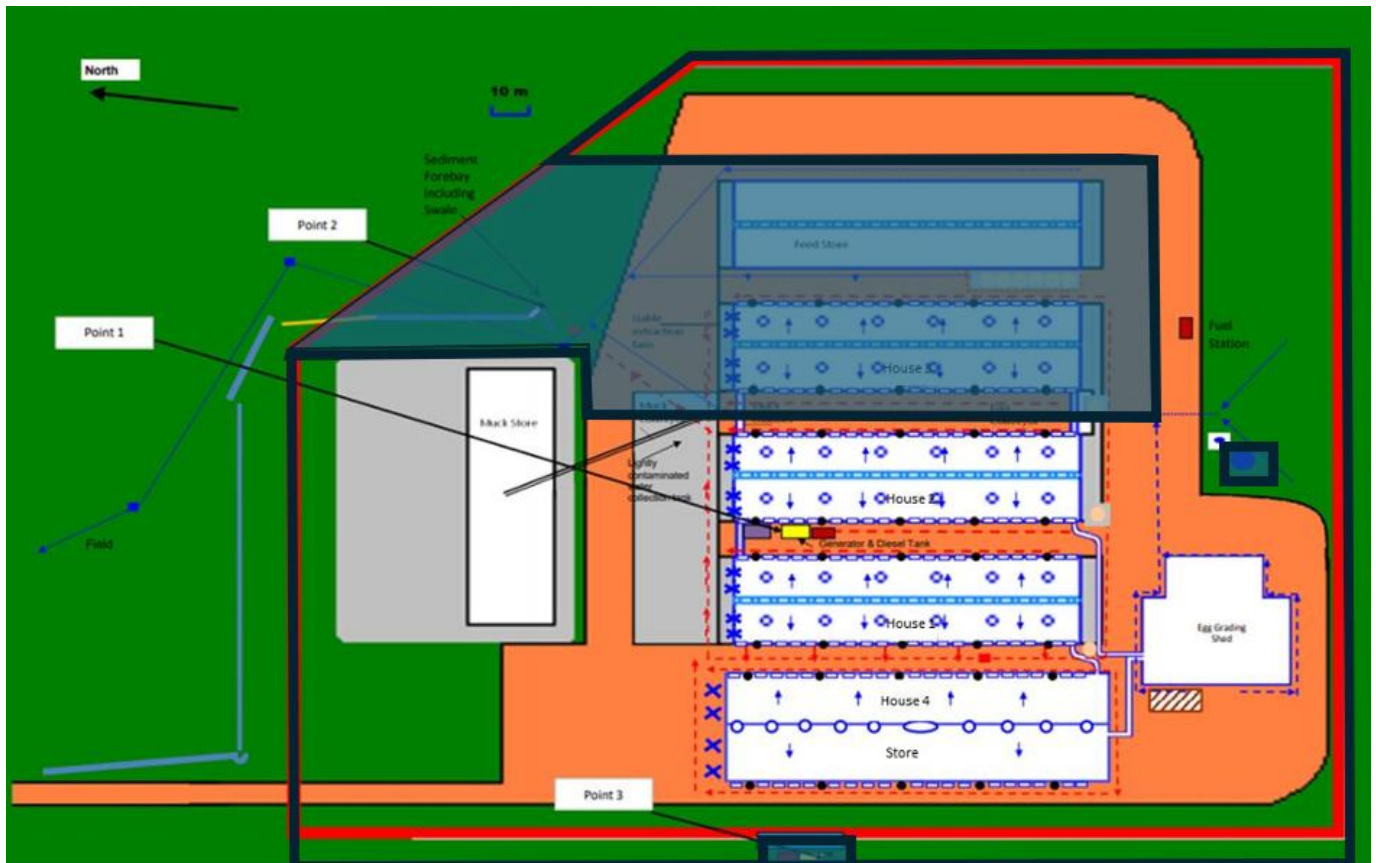

1.1.5.1.1 One bunded container for diesel, located as indicated on 1.2 Site Plan.

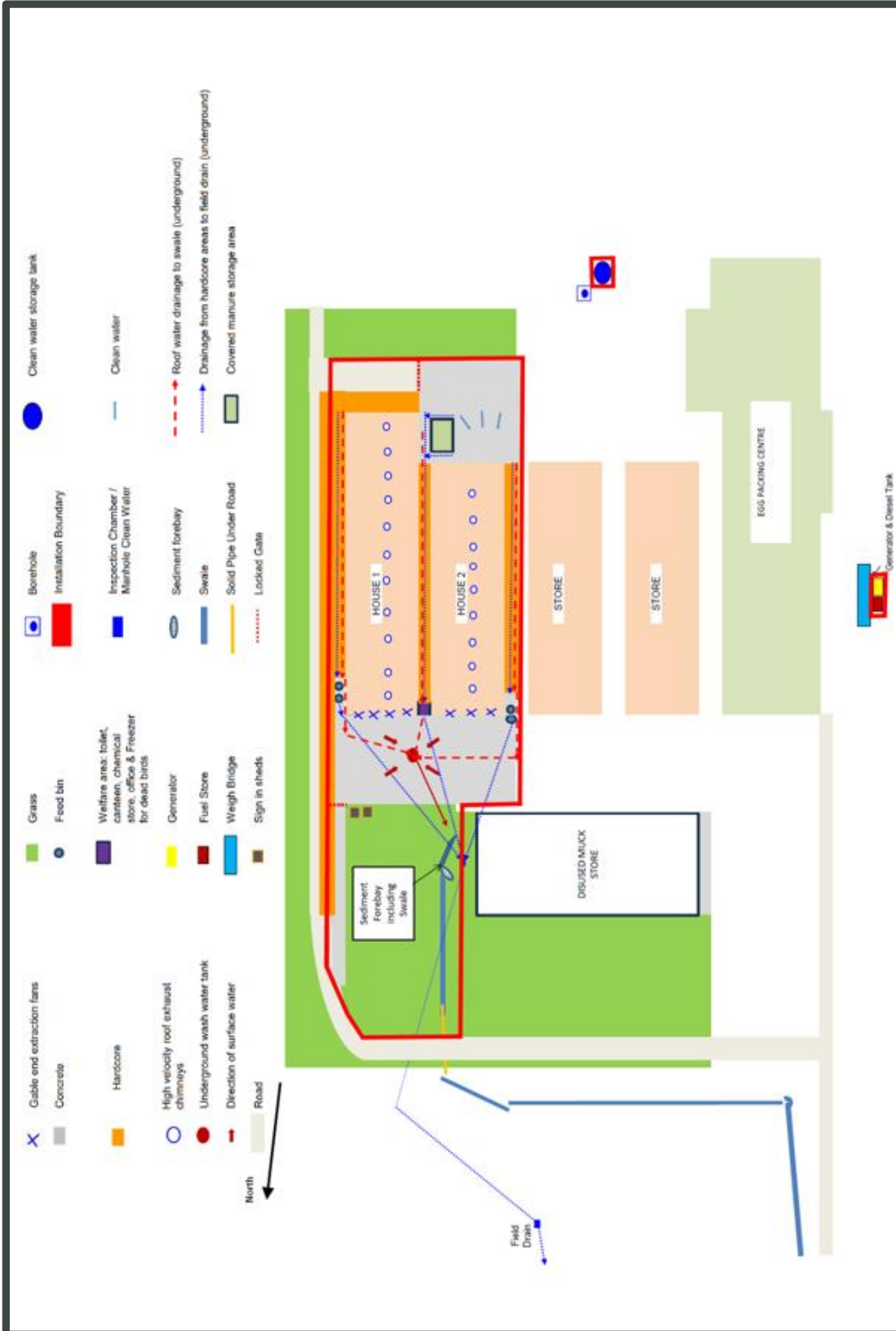
3. Condition 1.1.5.6 in Schedule 1 is deleted and replaced with the following
